<p>General Partnership (an unincorporated business Owned by two or more people)</p>	<p>1. Partnership Agreement -AND-</p> <p>2. Trade Name Registration Must contain "Filed" and Date Stamp from AZ Secretary of State Required if partnership does not include both members' first/last names -AND-</p> <p>3. Employer Identification Number (EIN)</p>
<p>Limited Liability Company (LLC) (a special kind of company that shares characteristics of a corporation and a partnership)</p>	<p>1. Articles of Organization Must contain "Filed" and Date Stamp from Arizona Corporation Commission -AND-</p> <p>2. Manager Structure Attachment Must be filed with Arizona Corporation Commission and contain the names of managers and/or members who are authorized to sign -AND-</p> <p>3. Employer Identification Number (EIN)</p>
<p>Limited Partnership (LP) Limited Liability Partnership (LLP) (these entities are neither LLC's or or General Partnerships)</p>	<p>1. Certificate of Limited Partnership (LP Only) Must contain "Filed" and Date Stamp from Arizona Corporation Commission Statement of Qualification (LLP Only) -AND-</p> <p>2. Annual Report (both LP and LLP) -AND-</p> <p>3. Employer Identification Number (EIN)</p>
<p>Corporation (Inc.) (an entity created by law, limiting liability to corporate assets. Ownership is evidenced by shares of stock and operated officers elected by a Board of Directors)</p>	<p>1. Articles of Incorporation including Certificate Filed with the Arizona Corporation Commission -AND-</p> <p>2. Corporation Annual Report and Certificate of Disclosure -AND-</p> <p>3. Corporation Bylaws -AND-</p> <p>4. Employer Identification Number (EIN)</p>
<p>Association/Union Account (an organization of two or more persons organized to promote a common interest)</p>	<p>1. Registration of the Association with the appropriate governing entity or Articles of Association -AND-</p> <p>2. Employer Identification Number (EIN)</p> <p>3. By-laws may be used in place of Articles of Association and/or registration of the association with appropriate governing entity.</p>
