

## **Idaho New Business Account Documentation Guide**

Sole Proprietor (an unincorporated business owned by one individual or a husband and wife)	<ul> <li>1. Certificate of Assumed Business Name (DBA form)</li> <li>Filed with the ID Secretary of State -AND-</li> <li>2. Employer Identification Number (EIN)</li> <li>Required only if business is not using sole proprietor's SSN</li> </ul>
General Partnership (an unincorporated business owned by two or more people)	<ul> <li>1. Statement of Partnership Authority</li> <li>Filed with the ID Secretary of State -AND-</li> <li>2. Employer Identification Number (EIN)</li> </ul>
Limited Liability Company (LLC) (a special kind of company that shares characteristics of a corporation and a partnership)	1. Certificate of Organization  Must contain "Filed" and Date Stamp from ID Secretary of State  -AND-  2. Operating Agreement  -AND-  3. Employer Identification Number (EIN)
Limited Liability Partnership (LLP) Limited Partnership (LP) (these entities are neither LLC's or or General Partnerships)	<ol> <li>Statement of Qualification of Limited Liability Partnership         <ul> <li>OR-</li> </ul> </li> <li>Certificate of Limited Partnership             <ul> <li>Must contain "Filed" and Date Stamp from ID Secretary of State</li></ul></li></ol>
Corporation (Inc.) (an entity created by law, limiting liability to corporate assets. Ownership is evidenced by shares of stock and operated officers elected by a Board of Directors)	<ol> <li>Articles of Incorporation with WA Unified Business Identifier (UBI number)         Must contain "Filed", File #, and Date Stamp from ID Secretary of State         -AND-     </li> <li>Corporation Bylaws         -AND-     </li> <li>Employer Identification Number (EIN)</li> </ol>
Association/Union Account (an organization of two or more persons organized to promote a common interest)	1. Unincorporated Nonprofit Association Appointment of Agent for Service of Process  Must contain Assoc. # and Date Stamp from ID Secretary of State  -AND-  2. Association or Union Bylaws  -AND-  3. Employer Identification Number (EIN)
Engine House Account (Fire Station House Dues Account)	<ol> <li>Copy of Bylaws (if they exist)         -AND-</li> <li>Completed Engine House Membership Agreement (with Captain's Signature)         -AND-</li> <li>Employer Identification Number (EIN)</li> </ol>
Additional Documents (Optional)	1. Copy of 501C Documentation (Certificate as a Non-Profit)  2. Service Residuation (Certificate as a Non-Profit)

**2.** Foreign Registration Statement (Non-ID Corp doing business in ID) Must be accompanied by an *original* certificate of corporate status from the

corporation's home state, dated within 90 days of filing
