Association/Union Account (an organization of two or more persons organized to promote a common interest)	<ol> <li>Association or Union Bylaws         -AND-</li> <li>Meeting Minutes with Elected Officers         -AND-</li> <li>Employer Identification Number (EIN)</li> </ol>
